**Winter weather** Firstly, a huge 'thank-you' to our facilities & estates teams for the significant amount of work they have carried out since Sunday to ensure roads and pavements on our sites are as clear as they can be in the current conditions.

The yellow weather warning for snow and ice remains in place across Grampian until 11.59pm on Thursday; please continue to check forecasts and the latest roads advice from both Police Scotland and your local council.

**The week in review – winter pressures** The NHS typically faces greater pressure in winter, both in the community and in hospitals. Thinking about whether this year is better or worse than last probably isn't the best yardstick to measure how it feels to work in healthcare. However, it does give us a point of comparison to understand the changing nature of health needs and how we are responding to them. This year we have made some changes in process in hospital to improve flow, including the introduction of 18 new beds in ARI. It's too soon to say what effect this has had but so far, how does winter 23/24 compare with winter 22/23? Looking at the 5-week period from the start of December to 7 January, demand for acute healthcare is higher than last year and more complex. ED attendances at ARI were 7% higher (approximately 370 more people coming through the front door), and we have seen an increase in 'majors' of around 10% (which means about 400 more of the total attendances were the most seriously ill). Waiting times in ED remain similar but turnaround times for ambulances improved, albeit remaining high. Dr Gray's saw a 35% increase in majors (about 520 patients) but managed small improvements in ED waiting times.

Across acute hospitals, we've seen an increase so far this winter in the number of admissions from ED adding pressure on bed occupancy levels which were higher and frequently above 100%, particularly in ARI. Respiratory illness is a big driver of demand in winter and although admissions from COVID-19 were higher than the same period last year, there are early signs that this surge may be reducing. New reported cases of influenza have reduced in the past week or so, yet GP consultations are still extremely high and comparable to the levels seen last winter (one of our worst flu seasons). We still have a lot of winter to go (as this week's weather proves) but we seem have come through the past 5 weeks with some positive signs.
