Here is the brief for Tuesday 18 January 2022.

Staff testing – updated flowchart The self-isolation exemption guidance for health and social care staff has been updated as of 17 January. The guidance removes the need for fully vaccinated staff who are identified as contacts to PCR test prior to returning to work. They should take an LFD test instead. If the LFD test is negative and provided they don't have a fever or other symptoms, staff can go back to work following a risk assessment by their line manager. They should also continue to take an LFD test every day for a 10-day period. All LFD tests should be recorded on the testing portal, and it is a requirement of the policy that managers ask for evidence of these results before staff attend work.

Staff that test positive should pause their workplace LFD testing for 28 days (from day 1 of symptom onset or positive test date). If they are also required to PCR test weekly, they should also pause this for a period of 90 days.

The flow chart, <u>available online here</u> and attached to the email used to send out this brief, has been updated to reflect this guidance.


Reminder: the advice and flow chart around Lateral Flow Devices [LFDs], testing and isolation is for students and learners in NHSG as well as for all staff.

Scottish Government update From Monday 24 January a significant number of protective measures will come to an end. Large indoor events can resume, restrictions on hospitality will be removed, and guidance on how many households can safely meet will be dropped. We are all still encouraged to take Lateral Flow Device tests before meeting others. COVID Vaccine Certification (sometimes called vaccine passports) remains in place, but it has not been extended beyond the existing scheme. Braun Infusion Devices The Medical Equipment Management Service (MEMS) have asked us to inform staff in clinical areas about the key difference between two Braun infusion devices in regular use. The Orange fascia pumps have a Critical Care configuration and the Green fascia pumps have a General configuration (see photo).



The difference in these configurations would mean that delivery of medication could be different to what the nursing staff would expect e.g., end of infusion alarms, maximum delivery rate, and start up messages. Unfortunately, incorrect devices have been found in both critical and non-critical care services. If you work in a non-critical care environment and find an Orange fascia pump (or find a Green fascia pump in critical care services) please contact MEMS on ext 52400 – they will arrange collection and return to the appropriate area.
