COVID-19Brief



Here is the brief for Tuesday 2 March 2021.

Scottish Government update – education The Scottish Government have confirmed today that it is their intention for all children in Primaries 4-7 to return to school on a full-time basis from 15 March. In addition, it is hoped all secondary school pupils will be spending at least some time in school between 15 March and the start of the Easter break, with priority given to pupils in S4-6 for in-school learning. It is planned that all secondary school pupils will return to school full-time after the Easter break. The government have stressed that safety in school is their highest priority; all local authorities will - at least until Easter - continue to observe the current requirement for 2m physical distancing in secondary schools and when secondary schools return, face coverings will need to be worn at all times. Variant of Concern detected in Grampian A significant amount of work has been undertaken over the last 48 hours to carry out enhanced contact tracing, related to the three cases of a COVID-19 variant of concern detected in Grampian. In addition to the usual Test & Protect strategy, local teams have also been establishing who the 'contact of contacts' may be and offering them testing, This isn't standard procedure but is being followed for these cases as an additional precaution. It is important to take this opportunity to highlight the rapid response of the local Public Health and Health Protection teams. As noted by the Chief Medical Officer our teams swung into action immediately and, as they have done throughout the pandemic, they have worked effectively and efficiently. We are extremely grateful to them for their efforts.

The National Contact Tracing Centre are working to trace those who were onboard BA Flight 1312 from Heathrow to Aberdeen on 29 January. Given not all the data they have received is correct, they are asking anyone on that flight who did not provide up-to-date contact details to call the NHS National Contact Tracing Centre on 0800 030 8012

COVID-19 vaccine and fertility We have all likely heard various claims about the COVID-19 vaccines. One of the most persistent suggestions is that the vaccines may impact fertility. The Royal College of Obstetricians & Gynaecologists has a clear statement on this, which we wanted to share with all health & social care staff:

There is no evidence to suggest that COVID-19 vaccines will affect fertility.


There is no biologically plausible mechanism by which current vaccines would cause any impact on women's fertility. Evidence has not been presented that women who have been vaccinated have gone on to have fertility problems.

Likewise, the theory that immunity to the spike protein could lead to fertility problems is not supported by evidence. Most people who contract COVID-19 will develop antibody to the spike and there is no evidence of fertility problems in people who have already had COVID-19.

As more evidence becomes available on the safety of each vaccine (from following up people for longer), we will update our advice.

Grampian data The local figures for today and the 7 day rolling positivity rate are shown below. As a reminder, this rate is arrived at by dividing the number of positive tests in the past 7 days by the number of tests carried out in the past 7 days. Repeat tests are included in both categories, whereas the figures we show here only record new tests.



Electronic Patient Record NHS Grampian aims to introduce a comprehensive, multi-professional, person centred, electronic patient record across the organisation by December 2021. We have taken the learning from a series of person-centred <u>records workshops</u> which many of you have been a part of and developed an initial build in TrakCare. We have started to test this in a live setting to further develop the processes. Initial testing in Ward 103 began at the end of January 2021. This fully supported testing involved the nurses continuing to enter into the patient admission assessment record (including patient placement tool) with the addition of medical staff entering medical clerking, senior review, and medicine reconciliation directly into TrakCare. All staff now contribute toward the patient's daily goal, problem list and continuous care record electronically.
