Missed appointments – GO Health Services/occupational health A recent review of the service has found a considerable number of unattended appointments for immunisations, blood monitoring, and management referrals. This creates unnecessary added demands on administrative and clinical resources and prevents our colleagues from accessing the service in a timely manner. Over the past 3 months, 30% of clinical time each month has been lost to failure to attend, or appointments cancelled within 48 hours. GO Health Services will now offer only one appointment. In the event a staff member does not attend, no further appointments will be scheduled.

If you do not attend for an immunisations or blood monitoring appointment, an immunisation clearance report will be sent to the manager. Please refer to Turas - Corporate: toolbox talk: immunisation clearance for information about manager's immunisation clearance reports. Should you wish a further appointment you will have to contact the service.

Where you do not attend for a management referral appointment, you will be sent a letter requesting you contact GO Health Services within 10 working days, and you will be offered the next available appointment. The referring manager will be informed. If you do not contact GO Health services within 10 days the referral will be closed, and your manager will need to re-refer you to GO Health Services if still needed.

**Public Emergency Alerts** On Sunday 23 April, the UK Government will test its Emergency Alert System. This enables it to send text messages to warn of issues such as flooding, storms, etc. The messages are broadcast from cell towers in the vicinity of an emergency, the alerts are secure, free to receive, and one-way. They do not reveal anyone's location or collect personal data.

Test messages will be sent in the early evening on 23 April and could be sent to anyone, anywhere, across the four nations. This short video explains more and includes an example of what the alert will sound like: (29) UK Emergency Alerts - YouTube
